Failure to provide accurate information will delay the processing of your claim. If you want to file an application for UC benefits, you may do so in one of the following three ways:

- 1) **Internet** - The fastest and most convenient method is to file using the online application at www.uc.pa.gov.
- 2) **Telephone** - Call the UC Service Center at 888-313-7284 Monday through Friday 8 a.m. to 4 p.m. (TTY access for the Deaf and Hard of Hearing is available at 888-334-4046.) Videophone service for individuals who use American Sign Language (ASL) is available every Wednesday from noon to 4 p.m. at 717-704-8474.
- 3) **Download** - Download and print an application at www.uc.pa.gov. (Mailed forms take longer to process.)

IMPORTANT: Failure to report all employment, gross earnings (earnings, vacation pay, holiday pay, hours absent, severance payments and pensions) for each week of unemployment that you claim may result in penalties up to and including fines, prosecution and liens on your property. Remember - gross earnings are reported when earned, not when paid.

Please Note: This form does not guarantee your eligibility for UC benefits. After you file your application for UC benefits, a determination of your eligibility will be made by the Department of Labor & Industry.
